5. TREASURERS REPORT

Jill discussed the percentage completed on the grant balances report and wondered if the Executive Director's adjustments in the % Complete column represent the percentage

complete for the Current Fiscal Year column on the grant balances report. Jill provided an explanation to new member Christine Williams about how to read the grant balances report. On the budget sheet, she explained revenues and expenditures and the need to see an increase in the budget so we can add at least something to the fund balance and not take from it, as we don't have a large fund balance to begin with.

7. EXECUTIVE DIRECTOR REPORT

Executive Director Dotty LaJoye reported that CUPPAD will be facilitating a transit study to evaluate and make recommendations on transit funding and service efficiencies for the counties of Delta, Schoolcraft, and Menominee. The budget is \$200,000, with \$30,000 going to CUPPAD for administration. CUPPAD is eligible to apply for another round of funding from MSHDA for \$75,000 vs \$150,000 for the previous grant cycle. CUPPAD will be applying but will not have a co-lead for the new grant cycle. The DNR announced that regional recipients of Spark grants, such as CUPPAD, can use the funds for the development of 5-year recreation plans and DNR grant applications in communities they previously assisted with successful Spark Grant applications. This is good news, and we appreciate the flexibility given to these funds. Before this announcement, we were only eligible to draw \$11,824.00 out of a \$48,000 grant for the time and assistance Julia Cogger provided to qualified communities in the region.

8.1 Employee Termination:

Lauren with Gabridge & Company joined via Zoom. The audit was positive. D. LaJoye provided a chart showing the positive trend the Commission has been on for the past 5 years. Audit questions should be submitted to Dotty by June 18th. T. Karlstrom would like to see the trend in membership. The action will be taken next month.

8.3 MDOT Resolution:

A resolution of support for CUPPAD's administrative role in the development of the public transit study was read and passed by a roll-call vote.
